Such notice shall entitle the Applicant to the return of any deposit made in connection with this Application not including the \$50.00 non refundable application fee. The failure of Applicant to timely notify the Community Manager shall result in a forfeiture by Applicant of the total amount of any such deposit. If this application is rejected, the Applicant hereby waives any claim for damages by reason of non-acceptance which the owner of his agent may reject without stating reason for doing so.

I authorize you to obtain an investigative credit report and criminal background investigation in connection with this application, including release of information by any bank, savings and loan, employer (present or former), landlords, and any other lender. I understand that I can request the name of the reporting agencies providing this information.
